Failure to provide the information requested below may result in you being classified as out-of-state for tuition and fee purposes. The responsibility for proper residency classification is placed upon the student and must be established prior to enrollment. Any student who falsifies his/her residency may be subjected to dismissal from the college and/or criminal action.
